## (LAW 207 OF 1989) THE PROTECTION OF COMPETITION LAW



Order under section 38 (Published in Supplement No. III(I) to the Official Gazette of the Republic No. 2532 of the 10th August, 1990)

The Minister of Commerce and Industry, in the exercise of his powers conferred upon him by virtue of section 38 of the Protection of Competition Law of 1989, after obtaining the opinion of the Commission for the Protection of Competition, makes the following Order.

Short title.

1. This Order shall be cited as the Protection of Competition (Applications, Notifications, Complaints and Publication of Decisions and Applications) Order of 1990.

## Interpretation

2. (1) In this Order

"Commission" means the Commission for the Protection of Competition within themeaning of section 8 of the Law;

means the Protection of Competition Law of 1989.

- (2) The terms used in this Order which are not otherwise defined, shall have the meaning assigned to those terms by the Law.
- 3. This Order shall prescribe, as specified in the Annex, the form, content and manner of submission and registration of
- (a) the applications for individual negative certification or individual exemption under sections 16(3) and 18(3) of the Law:
- (b) the notifications effected under section 21(1) of the Law; and
- (c) the complaints submitted under section 28(3) of the Law:

Publication of decisions and applications

- 4. (1) The summary of the decisions\* of the Commission on matters falling within its jurisdiction and the reasoning of decisions shall be published in the official gazette of the Republic.
- (2) Each application submitted to the Commission for the granting of an Individual Negative Certification or Individual Exemption shall be published in summary in the official gazette of the Republic.
