IT IS HEREBY DECIDED

To accept the surrender of all types of categories of Cambodian textiles and textile products which are subject to quantitative limitations by the Government of the United States of America from the following Cambodian Garment Manufacturers as listed in Annex 1 of this Prakas.

Article 2:

To allocate the above surrendered quotas to other Cambodian garment manufacturers as listed in Annex 2, based on the three following criteria:

• the company has available purchase orders from American buyers;

- the company already has in its warehouse some unsold textile products; and
- the company has enough manpower and machinery to produce and export the said quantity before December 31, 1999.

Article 3:

Based on the limited time to utilize the surrendered quotas, the Export Quota Management Committee will not charge any fee other than the regular Export Quota Management Fee (EQMF) and the Administrative Fee for the issuance of Commercial Invoices/Export Visas.

Article 4:

All companies that are allocated surrendered quotas have an obligation to fully utilize them before December 31, 1999. Unused allocated quotas exceeding 5% of the amount allocated would be charged three (3) times the value of the Export Quota Management Fee (EQMF) for each specific category and three (3) times the amount of the Riels 120,000 administrative fee for the issuance of Export Visas.

Article 5:

The Director of Cabinet, the Technical Director General, the Director of CAMCONTROL Department, the Director of the General System of Preferences Department, and all garment manufacturers shall implement the present Prakas.
